## Town of Mocksville Regular Board Meeting December 7, 2021

The Town of Mocksville Board of Commissioners met for the Regular Board Meeting on Tuesday, December 7, 2021 at 6:00 p.m. in the Mocksville Town Hall building located at 171 S. Clement Street.

Mayor Marklin called the meeting to order.

The Town of Mocksville Board paused for a moment of silence.

Mayor Marklin led the Pledge of Allegiance.

### **Adoption of Agenda**

A motion was made by Commissioner Williams to adopt the agenda as written. The motion was seconded by Commissioner Taylor which carried by a unanimous vote 5-0.

#### **Citizen Comments**

Mayor reads; Under GS section 160A-81.1, the Board shall provide one period for public comment per month. Public comments are a valued part of the Board meeting but we also have to handle monthly business items. If your public comment is not heard this month we provide the same opportunity at each month's Board meeting. Public comments are limited to 3 minutes per comment. The Mayor asks that groups appoint spokespersons for groups supporting the same position, especially when the number of people wishing to attend the meeting exceeds the capacity of Town Hall. When the comments become repetitive and no longer provide new information then discussion for this meeting may be stopped. As a

reminder, the comment period is not a question and answer session. As always, the Mayor shall provide for the maintenance of order and decorum in the conduct of the comment period.

### **Consent Agenda**

A motion was made by Commissioner Vaughan-Jones to adopt the consent agenda as presented. The motion was seconded by Commissioner Southern which carried by a unanimous vote of 5-0. Items approved were: (A) November 2, 2021 Regular Board Meeting (B) Monthly Financials and (C) Tax Releases.

### Consider Appointment of Mayor Pro-Tem for the Town of Mocksville

A motion was made by Commissioner Frye to appoint Rob Taylor as Mayor Pro-Tem. The motion was seconded by Commissioner Draughn which carried by a unanimous vote 5-0.

## Consider Piedmont Triad Regional Council (PTRC) Board of Delegates (BOA) Appointment and Alternate

Representatives from each county and municipality meet once a month to receive updates regarding federal funding, housing and workforce development. This person also serves on the Transportation Advisory Committee. This is where a need for a road or an intersection change would be presented and to receive Department of Transportation representation. It is two meetings in one. This also allows you to meet others that serve.

If the situation arises that the Representative could not attend, the alternate would go to the meeting instead.

A motion was made by Commissioner Taylor to appoint Commissioner Johnny Frye as PTRC Board of Delegates and Commissioner Justin Draughn as the Alternate. The motion was seconded by Commissioner Lambert which carried by a unanimous vote 5-0.

## Consider Northwest Piedmont Rural Planning Organization (NWRPO) Transportation Advisory Committee (TAC) Appointment and Alternate

A motion was made by Commissioner Taylor to appoint Commissioner Johnny Frye as NWRPO Transportation Advisory Committee representative and Commissioner Justin Draughn as the Alternate. The motion was seconded by Commissioner Draughn which carried by a unanimous vote 5-0.

### **Consider Ordinance Amendments to Comply with SB300**

Town Attorney Benshoff addressed the Board. The General Assembly amended General Statue 160A-175 to state that no town ordinance may be enforced criminally after November 20, 2021, unless the Town Board adopts specific ordinance specifying precisely what sections may be enforced by a criminal action. Amendments to the ordinance will need to be presented and adopted twice before the Board.

A motion was made by Commissioner Lambert to adopt amendments to ordinances as written to comply with SB300. The motion was seconded by Commissioner Taylor which carried by a vote 5-0.

This will be on the January agenda also. It has to be presented twice before the Board.

### **Consider Ordinances to be Repealed**

Town Attorney Benshoff addressed the Board. Article 2 should be repealed because the General Assembly reversed the statute giving Town the authority to charge these licensing fees. Article 5 is not needed. It largely repeats N. C. General Statutes Chapter 19. When the Town needs to bring a nuisance action , it would be brought under Chapter 19.

A motion was made by Commissioner Taylor to adopt ordinances to be repealed. The motion was seconded by Commissioner Draughn which carried by a vote 5-0.

## Consider Amending Code of Ordinances Chapter III General Regulations, Article 1: Animals and Fowl; Restraint of Animals

Town Manager Gamble addressed the Board. In 2017, the Board of Commissioners adopted Davie County's animal control ordinance that did not include a leash law provision. This ordinance will require dogs to be on a leash when off the owner's property and address the tethering of dogs. Davie County animal control will enforce this law. This ordinance needs to be presented and adopted twice before the Board.

A motion was made by Commissioner Frye to adopt amendments to the code of ordinances Chapter III general regulations, article I: animals and fowl; restraint of animals. The motion was seconded by Commissioner Lambert which carried by a unanimous vote 5-0.

This will be on the January agenda also. It has to be presented twice before the Board.

### Consider Budget Amendment FY 21-22 #2

A motion was made by Commissioner Taylor to adopt budget amendment #2 in the amount of \$252,817 for projects Angell Knoll Road and Wilkesboro & Sofley Street that was not completed until FY 21-22. The motion was seconded by Commissioner Frye which carried by a vote 5-0.

### **Consider Records Retention and Disposition Schedule Resolution**

The 2021 Program Records Schedule for Local Government Agencies is a new retention schedule created from the former County Management (last updated in 2013) and Municipal (last updated in 2012) retention schedules. This schedule contains specific functions of government at the county and municipal level. This schedule contains a standard for Law Enforcement records, but County Sheriff's Offices should continue to use their specific standalone schedule. Similarly, the schedule also contains a Tax Records standard. County Tax Administration offices should continue to follow the County Tax Administration schedule.

A motion was made by Commissioner Lambert to adopt the October 1, 2021 revision amendments to the retention and disposition schedule resolution issued by the NC Department of Natural and Cultural Resources and Division of Archives and Records. The motion was seconded by Commissioner Frye which carried by a vote 5-0.

### **Consider 2022 Meeting Schedule**

A motion was made by Commissioner Draughn to adopt the 2022 meeting schedule. The motion was seconded by Commissioner Stevenson which carried by a vote 5-0.

This schedule can be revised by the Board at a meeting.

# Consider Resolution Regarding the Designation of an Official to Make Recommendations to the North Carolina Alcoholic Beverage Control Commission on ABC Permit Applications

Town Manager Gamble addressed the Board. Due to the Town transitioning to the Davie County Sheriff's Office, there needs to be a designee update. This resolution designates the Town Manager to make recommendations to the North Carolina Alcoholic Beverage Control Commission on ABC Permit Applications.

A motion was made by Commissioner Frye to adopt the resolution regarding the designation of an official to make recommendations to the NC alcoholic beverage control commission on ABC permit applications. The motion was seconded by Commissioner Taylor which carried by a vote 5-0.

### **Consider Contract for ORC Duties with Davie County**

Town Manager Gamble addressed the Board. Due to an employee leaving, the Town no longer has an "ORC", Operators in Responsible Charge for distribution systems, which pushes all the water to our customers and the collection systems, which is a collection of pipes that takes all sewer away from our customers. This ORC Agreement is using Davie County professionals until Town staff is trained, which is more cost effective compared to using Envirolink as the ORC.

A motion was made by Commissioner Draughn to adopt contract for ORC duties with Davie County. The motion was seconded by Commissioner Lambert which carried by a vote 5-0.

## Public Hearing to Consider Naming the Unnamed Softball Field at Rich Park After Julius E. Suiter.

The Board of Commissioners received a nomination to name the field for Mr. Suiter for his exceptional contributions to the community as an educator, principal, volunteer and non-profit board & church member.
