Concession Stand – Pre-Packaged Food – No Permit
Other than Pre-Packaged Food – Permit Needed

Park Rules:

- No Alcohol, Drugs or Firearms allowed at any event – NO EXCEPTIONS!
- Facility should be left as found. Picnic Tables must not be moved.
- Abusive language and/or behavior may result in expulsion from the park.
- Parks Grills are designed for charcoal only. It is unlawful to gather and burn wood on Town park property. Personal Grills may be used. Grills must be used outside the shelters.
- NO open fires.
- NO Refunds. Rain dates will be scheduled during the same season if available at the same or comparable location. Rain dates must be requested within 48 hours of original rental date.
- **The use of the concession stand at Mando field or softball field, will require a permit from Davie County Health Department to prepare or serve any concessions other than pre-packaged items.**

(Please contact Davie County Health Department if you have any questions regarding permit or food preparation procedures. The Town of Mocksville shall not be liable for any violations or health related incidents regarding the preparation and serving of food at concession stand facilities.)

I am reserving a Town facility and understand that I am accepting responsibility for usage of the shelter and/or field and will be liable for the cost of clean-up and/or any damages incurred as a result of this activity. I understand that law enforcement and town staff have the final authority to end any rental due to disregard of park rules, violations of the law or unsafe activities. If my rental is ended for the reasons outlined above, I understand that I am not entitled to a refund of the rental fees.
